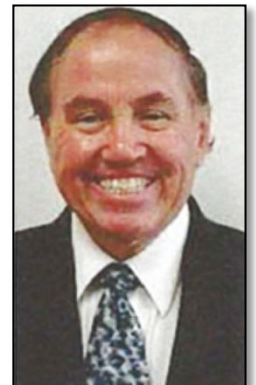

100 DAYS BEFORE TRIAL: A LAWYER'S GUIDE TO PREPARATION AND STRATEGY

Presenter Richard Lawrence Scott will provide a guide for good practices in the final 100-day period before a trial, which is in some ways the most critical stage of any proceeding. This “twilight zone” between the completion of discovery and the opening statement can be the difference between winning and losing a case. Exceptional trial skills will rarely rescue a case that is not properly “teed up” for delivery to the trier of fact at the start of a trial or arbitration.

Attorney **Richard Lawrence Scott** recently retired having served 22 years with Travelers Insurance Company as a senior litigation attorney. In 2010 he received the Travelers Outstanding Trial Results Award.
